- b. Data Collection Updates
 - 1. Alert to the Board regarding the collection of social security numbers and cards at the school level.
 - i. Board rules schools must store social security numbers, government issued IDs in the permanent files, and place the information on the enrollment form (required this for numerous years) and submit using the secured portal (For the past 10 years). We made an adjustment having schools submit the information they already collect and store which provides us with the official documents that goes with the person attending school, moving through exam and licensure.
 - ii. Staff is working on removing the schools from the collection, but not ready to disclose at this time. It will require database programming and rule changes once the solution has been found.
- c. Civil penalties
 - 1. FYTD 2023 \$131,520.00
 - 2. September 2023 \$40,465.00
 - 3. The Board only keeps 20% of all penalty collections
