- c. Rule Waivers
 - 1. 14T .0701(p) Enrolled students may earn a maximum of 10 hours per day per discipline of cosmetic art and a maximum of 48 hours per week per discipline. Online education can be earned in addition to the maximum daily and weekly hours. The board provided a waiver to this rule when it pertains to internship. A poll of the board was conducted, and all members voted unanimously to include internship hours with the online hours.
 - 2. School Due to hurricane Helene in the Western part of the State A poll of the Board was conducted to allow current licensed schools to bring in portable sinks temporarily until they can get the water safe for use. The board members voted unanimously to allow for portable sinks only until water usage is restored and safe for use. The schools need to ensure only safe, sanitary services are provided, Board infection control procedures are followed, bathroom facilities are kept clean.

A motion was made by Tana Tucker to ratify a poll vote and waivers for portable sinks for schools for impacted Hurricane Helen. The motion was seconded by Robert Chandler, motion passed.

 - g. School Inspection Rubric I have broken it out into two section.
 - 1. We have 17 questions regarding school operating schedule, including students' attendance and client access with client service amounts. These 17-question document is given to the school upon arrival so they can complete as the inspector is doing the sanitation and observation portion of the Rubric. By the end of the year, we will have an electronic version of these questions and audit questions that the school will need to respond.
 - 2. The inspectors complete the observation portion of the rubric.
 - 3. School student file Audits are including I have added the number of school hours per week compared to the number of open clinic hours per week percentage to the schools' audit report. Schools are required to submit corrections to the audit finding. Schools are reaching out to me regarding their findings, allowing for great conversation. Many school after this conversation have increased their clinic hours. In some cases, I have found the schools were reporting first and last client hours not the actual time the students are working on the clinic.
